Who Is Conducting The In-Person Visit and What Will I Be Asked To Do?

A certified phlebotomist or a licensed practical nurse from the 3Gs team will complete the visit. The visit can be conducted at your mom's home or another location that is convenient for you and your mom. The visit will take approximately thirty minutes per person.

As part of the in-person visit, you will be asked to:

- have measurements taken of your blood pressure, height, weight, and waist size
- give samples of your blood, urine, and saliva, and give consent (permission) for each of these samples
- fill out a questionnaire about your health history and health behavior

Do I have to do the questionnaire before the visit?

No, you can complete the questionnaire anytime before or after the visit. The questionnaire can be completed online or we can mail you a paper copy if you prefer. This questionnaire should take you approximately 20-30 minutes to complete.

Will I Be Compensated For The In-Person Visit and Questionnaire?

In recognition of the time you will be contributing to this research effort, you will receive \$50.00 for completion of the in-person visit and \$25 for the time it will take you to complete the questionnaire.

Where Can I Find Detailed Information About The Visit?

We have posted a copy of the consent form on our website. If you have questions or concerns that you need answered before the scheduled visit, please call or email the study staff. The examiner will bring copies of the form to the visit and confirm that all of your questions have been answered before you sign the form. You may keep one copy for your records.

What Will You Do With My Samples?

Your blood sample may be tested for chemicals suspected to be environmental contaminants. Environmental contaminants include chemicals used in the growing of food (pesticides), gardening and household cleaning (fungicides), chemicals used to make household products resistant to fire (flame retardants) and industrial chemicals which may be present in the environment. Your blood, urine and saliva samples will be stored for future studies of women's health, environmental exposures, and how health is related across generations within a family.

How Will My Information Be Kept Private?

If you chose to participate in the study, your identifying information will be kept completely confidential by study staff. Each person in the study is given an ID number and only this ID number will be used on study materials. The blood, urine and saliva samples will have a bar code with this number and your name will not appear on the tubes. All study materials will be stored in locked file cabinets in restricted-access areas.

How Can I Schedule A Visit?

We will be contacting your mom to schedule the visit. Please contact your mom and discuss your best time to do a visit. If you are unable to complete the visit at the same time as your mother, we are happy to schedule a separate visit. Please call our scheduling hotline below.
